1. A limit of 5 (five) Largemouth Bass may be transported and weighed in per team. Minimum length is 12 inches. A short fish brought to the scales will result in disqualification of the entire catch. Weighing in of a dead fish results in a 1 (one) pound penalty. Two teams may share a Pontoon or deck boat but must be considered separately as two teams
2. A Coast Guard approved vest must be worn at all times while the boat is on plane.
3. **Boat check in will be at 6am** at Lakeside Inn Dock. Fishing will be on the six lakes on the Alligator chain of Lakes. **First Blast-off time for groups #1 – 30 is at safe light-weight in at 2:00pm. Second Blast-off time for groups #31- 60 is 20 minutes after - weigh in at 2:20pm.** Competitors who are not checked in by the 2:00/2:20 pm tournament close will be penalized at the rate of 1 pound per minute, up to 10 minutes at which time their catch will be disqualified..
4. **Live bait or artificial baits may be used. No trolling or snagging!!**
5. Sportsmanship - No team may fish within 50 yards of another competitor who is anchored with the trolling motor up. No team may fish within 25 yards of another team without the other team's permission. No hole sitting by a non-competitor or by another competitor, to aid a Team. All Teams are required to abide by state and federal laws. Harmony Youth Football and FOMMI reserve the right to a give Polygraph Test prior to awarding prizes.
6. Any protest must be submitted in writing to the Tournament Board within 10 minutes of close of weigh-in. Tournament Board Members are Scott Urban and John Higgins. Interpretation of these rules will be left to the Tournament Board. Infractions of any rule can result in disqualification.
